### **2. Purposes of processing and legal basis**

The personal data is used for communication with you. As a rule, this involves pre-contractual measures and contract performance, i.e., also answering your inquiries. The legal basis for this is Art. 6 para. 1 lit. b) DSGVO.

We use junk/spam filters for email communication. Our legitimate interest here is the protection of our systems. The legal basis is Art. 6 para. 1 lit. f) DSGVO.

You can assert your right to information pursuant to Art. 15 DSGVO against the above-mentioned controller. The processing for this purpose is based on Art. 6 para. 1 lit. c) DSGVO.

### **3. Types/categories of data and data subjects**

These personal data are processed: Name and contact details, possibly email address (here are technically necessary: server and IP address), as well as all information that you provide us with or are necessary for fulfillment.

These are the data subjects: all the people involved in the communication.

### **4. Receiver**

Within EBARA Precision Machinery Europe GmbH, your personal data will only be transmitted to those persons who are necessary for the processing of the underlying facts (e.g., in the context of the preparation of offers, clarification of content-related issues, billing).

## **5. Third country**

For all other communication channels, no transmission to a third country takes place.

## **6. Duration of storage**

In principle, your personal data will only be stored for as long as is necessary for the purpose,

## **7. Right to information, correction, deletion, restriction, data portability**

In principle, you have the right to request information free of charge about

- the data we process,
- the purposes of processing,
- the categories of personal data that are processed,
- where applicable, the (categories of) recipient(s) to whom the personal data have been or will be disclosed (including, where applicable, appropriate safeguards if a transfer of the personal data takes place outside the EU) and, where possible, the planned duration for which the personal data will be stored or, if this is not possible, the criteria for determining this duration,
- and, if applicable, about the origin of the data.

If applicable, you have a right to have the personal data concerning you corrected or deleted, or to have us restrict processing. If applicable, you also have the right to object to the processing. Insofar as you have given your consent, you may revoke it at any time with effect for the future. And according to Art. 20 DSGVO, you also have the right to data portability.

## **8. Origin of the data**
